



SUBJECT: Establishment of Assignment Incentive Pay for Qualifying Cold Weather Locations



AIP Pay Levels	W/O Dependents	With Dependents	Criteria
Level 1	\$500	\$1,000	Above -20°F with additional substantiating need
Level 2	\$1,000	\$2,000	-20°F through -29°F
Level 3	\$1,500	\$3,000	-30°F through -39°F
Level 4	\$2,000	\$4,000	-40°F through -49°F
Level 5	\$2,500	\$5,000	-50°F and below

AIP-CW is a lump-sum incentive pay designed to both incentivize assignment as well as to ensure the readiness, health, and safety of service members and their dependents. The upfront payment of AIP-CW assists service members with defraying the initial costs associated with the purchase of cold-weather items necessary to safely live and work in an extreme cold-weather environment which may otherwise prevent an Airman or Guardian from pursing assignments to and remaining at these locations. The following locations qualify for AIP-CW based on the DAF's cold weather criteria:

CLEAR	4	\$2,000	\$4,000
EIELSON	4	\$2,000	\$4,000
GRAND FORKS	2	\$1,000	\$2,000
JB ELM-RICH	2	\$1,000	\$2,000
MALMSTROM	2	\$1,000	\$2,000
MINOT	2	\$1,000	\$2,000

Subject to re-authorization, AIP-CW is authorized through December 31, 2026. In accordance with DAFI 36-3012, para. 3.3.2 and HAFMD 1-24, para. A1.158, SAF/MR may adjust or eliminate AIP-CW prior to the established end date at any time during the authorized period. The Air Force Personnel Center shall provide an annual status update to AF/A1PA and SF/S1PA as required by DoDI 1340.26.

While AIP-CW is effective as of April 1, 2024, implementation will take additional time; the anticipated first pay date is July 1, 2024. Payment will be retroactive to April 1, 2024. The Deputy Chief of Staff, Manpower, Personnel, and Services will issue implementing DAF guidance to the field as soon as practicable.
