SUBJECT: DAF Implementing Policy on Prioritizing Military Excellence and Readiness

Pursuant to the May 6, 2025, United States Supreme Court ruling granting the U.S. Government the requested stay of the preliminary injunction in *Shilling v. United* States, the Secretary of Defense issued reference (i), reinstating references (b) through (d), (f), and (g) effective immediately. Furthermore, reference (h) is rescinded (except for that portion which addresses use of "preferred pronouns") and reference (e) is reinstated effective immediately.

Airmen and Guardians who self-identified as having a current diagnosis or history of, or exhibit symptoms consistent with, gender dysphoria and initiated the process for voluntary separation or retirement prior to March 26, 2025, will have their applications processed accordingly following resubmission of their application. In accordance with reinstated policy as outlined in reference (i), the eligibility window to resubmit a previous application or self-identify with a new voluntary separation or retirement application is extended to June 6, 2025, for Active Component members and July 7, 2025, for Reserve Component members.

Commanders should be proactive in communicating the self-identification period and opportunity to initiate voluntary separation or retirement with the force.

At the conclusion of the self-identification eligibility window, the DAF will initiate involuntary separation processes pursuant to the Office of the Under Secretary of Defense for Personnel and Readiness Memorandum "Prioritizing Military Excellence and Readiness: Military Department Identification," March 21, 2025. Updated procedural guidance will be issued as soon as possible.

As stated in reference (e), all Exceptions to Policy granted pursuant to DAFPM 2021-36-01, *Accessions and In-service Transition for Persons Identifying as Transgender*, are hereby rescinded and commanders have the authority to place members on administrative absence while they are being processed for separation or retirement.
